Junk Vehicle and Boat/RV Disposal Program

Columbia Resource Company (CRC) will accept and dispose of a variety of watercraft, recreational vehicles (RV) and all terrain vehicles (ATV). In order to ensure the safe and proper disposal of these vehicles, CRC has implemented the following program.

Locations -

Boats, RVs and ATVs are accepted at Columbia Resource Company's CTR and West Vancouver locations:

Rates –

The standard 'per ton' MSW rate (plus transaction fee and tax) applies to the disposal of the aforementioned vehicles. Additionally, a special handling fee of \$80 per vehicle (ATVs, motorcycles, scooters and Jet Skis excluded) will be charged at the time of payment. If there is any Freon containing materials, they must be declared upon entrance of the facility and will be charged the current rate for Freon disposal.

Note: A waiver must be signed by the customer if CRC equipment is requested in the unload process.

Boats/Watercraft -

Boats/Watercraft will be accepted under the following conditions:

- The vessel is under 30 feet in length for West Van and 20 feet for CTR
- Provide the title or Affidavit in Lieu of Title
- Coolant, engine oil and fuel tanks are emptied (Inboard fuel tanks must be punctured and/or shown to be empty)
- All other tanks emptied (potable water, black water, grey water, etc.)
- All Freon materials declared (A/C units, Refrigerators, etc.)
- All batteries disconnected and removed

Note: In the event the customer requires the use of CRC equipment in the unloading of a vessel, the customer will affix the chain/strap to the vessel while the CRC operator will attach the chain/strap to CRC

equipment. The customer will then pull their vehicle forward while CRC equipment is stationary. All instruction by CRC employees must be followed. If CRC instructions are not followed, CRC reserves the right to stop the unloading/disposal process and refuse service.

Recreational Vehicles (Travel trailers) –

Columbia Resource Company will accept travel trailers and tent trailers under the following conditions:

- The RV is under 30 feet in length for West Van and 20 feet for CTR
- Provide the title or Affidavit in Lieu of Title
- An asbestos survey is provided for any vehicle constructed before 2004
- Fuel tanks are emptied (fuel tanks must be punctured and/or shown to be empty)
- All other tanks emptied (potable water, black water, grey water, etc.)
- Freon materials declared (A/C units, Refrigerators, etc.)
- All batteries disconnected and removed

CRC does not accept motor home recreational vehicles (RV with drivetrain)

All Terrain Vehicles (ATV)/ Motorcycles and Scooters –

Columbia Resource Company will accept ATVs, motorcycles and scooters under the following conditions

- Provide the title or Affidavit in Lieu of Title
- Coolant, engine oil and fuel tanks are emptied (fuel tanks must be punctured and/or shown to be empty)
- All batteries disconnected and removed

Vehicle Titles –

If you do not have the title to the boat /RV:

Note the license plate and vehicle identification number (VIN), take that information to your local vehicle licensing agent's office, and request an Affidavit in Lieu of Title.

Note: Vessels brought in by law enforcement (or other government agencies) will be accepted without a title, provided the other conditions are met.
