Propane Tank	\$ 22.00 each	Includes refrigerators, freezers, air conditioners, water coolers, etc.
Appliances w/refrigerant**	\$ 63.00 each	** Whole or partial units; With or w/o coolant
Noxious Weeds	\$108.78 per ton	Noxious Weeds: any load that contains Noxious weeds & invasive species such as blackberries/ivy will be subject to charge. \$25.20 minimum charge for the first 480LBS
Tires	with rim \$17 each. Without rim \$12 each	
Mattresses /Box springs	4 or less pieces are charged at the garbage rate; 5 or more are \$60 per piece.

ORGANIC RECYCLING – YARD WASTE

Pierce County RESIDENTIAL OR COMMERCIAL YARD WASTE

COST: \$110 per ton for loads that are a ton or more in weight. Loads less than a ton are free. Yard waste is weighed before and after unloading. A ton is 2000 lbs.

***All loads must be completely unloaded in one trip before exiting the site.**

ALLOWED MATERIALS

- Grass clippings
- Leaves
- Weeds
- Brush
- Sod
- Branches
- Bark, clean sawdust, wood chips
- Stumps (must be able to hand unload)
- Firewood



Sod can be no thicker than 2 inches overall. No rocks and no plastic netting. Dirt cannot exceed 1½" of the sod.

OUT OF COUNTY YARD WASTE

In accordance with the Agreement between LRI & Pierce County, out of County Yard Waste will be charged **\$110.00 per ton with a minimum charge of \$36.23 that covers the first 620 pounds.**

POLICY REGARDING

EQUINE MANURE, STRAW & HAY

- **Equine Manure** is charged at **\$75 per ton** with a **\$24.75** minimum which covers the first 660 lbs; this includes straw or hay that has been used as bedding.

Straw and Hay NOT used as bedding, may be brought in with yard waste.

LANDCLEARING CHARGE - \$80.00 PER TON WITH A \$24.80 MINIMUM which covers the first 620 lbs.

YARD WASTE THAT IS CHARGED AT THE LANDCLEARING RATE:

- Stumps or yard waste that cannot be hand unloaded
- Dump trucks with tandem axels or pup trailers
- End Dumps
- Side Dumps



MATERIALS NOT ALLOWED

IN YARD WASTE

- Rocks, Pebbles, Sand or Dirt
- Food Waste, Plastic or Trash
- Bricks, Glass or Metal
- Twine or Wire
- Dog or Cat Waste
- Manufactured or processed wood such as plywood, lumber, and fencing.
- Noxious Weeds or Fibrous plants

NOTICE! ABSOLUTELY NO TRASH IS ALLOWED IN YARD WASTE!

Loads containing any materials not allowed will be charged at the full garbage rate. If these non-allowed materials are found in yard waste, **YOU WILL BE CHARGED** for the whole load at garbage rates at the scale house on your way out. All Yard Waste **MUST** be removed from containers (bags, boxes) when unloading.

E-WASTE – ELECTRONICS RECYCLING PROGRAM

What is E-Waste?

E-Waste is just about anything electricity runs through. E-waste is a popular, informal name for electronic products nearing the end of their "useful life". Computers, monitors, televisions, and more listed below are common electronic products. Many of these products can be reused, refurbished, or recycled.



Unfortunately, electronic discards are one of the fastest growing segments of our nation's waste stream. Many components or electronic equipment – including metals, plastic, and glass – can be reused or recycled, while others may present environmental hazards if not managed correctly. It is our goal at LRI to manage this ever-increasing waste efficiently and effectively.

USED ANTIFREEZE AND MOTOR OIL RECYCLING PROGRAM

- Use a **clean** container for draining oil or coolant from your vehicle, boat, or lawn mower. **HINT:** Use a reusable container (5 gallon maximum) with a good lid.
- Puncture and drain oil filters for 24 hours before throwing them in the garbage.
- Oil and coolant containers must be recycled, reused, or disposed of properly. Garbage rates will apply to the disposal of oil or coolant containers.
- Oil and coolant must be in a transferable container.
- Disposal limit is five (5) gallons per trip.
- **Never** mix oil with any other substance. Solvents, gas, brake fluid are accepted @ Hidden Valley on Tuesdays and Thursdays 8am-12pm and 1pm-5pm.

The Recycling Center at Hidden Valley provides self-haul customers the opportunity to recycle their sorted recyclable materials before entering the disposal site.
